

Spin: Terms & Conditions

By accepting the terms and conditions of Spin, you agree to the following:

Rules and Regulations :

- 1- The products that are won are samples and cannot be sold, exchanged, returned or traded commercially. Same applies for all the points or different services that are provided by SPIN.
- 2- All the points and / or the services won by any participant cannot be transferred to any other participant. They cannot be sold or exchanged under any circumstances.
- 3- All the points or services earned on the application platform have no monetary or real value outside of the platform itself.
- 4- SPIN is not responsible for inappropriate use, application or other related misuse of products or services that have been won on the platform.
- 5- If you are unable to collect your redeemed gifts and services you cannot claim them back after the delivery schedule.
- 6- Entering false or inaccurate information may result in your account being deactivated.

1. License

1.1. Grant of a Limited License to Use the Service

Subject to your agreement and continuing compliance with these Terms of Service and any other relevant SPIN policies, SPIN grants you a non-exclusive, non-transferable, non-sublicensable, revocable and limited license to access and use the Service for your own non-commercial entertainment purposes. You agree not to use the Service for any other purpose. The following restrictions apply to the use of the Service:

- You shall not create an Account or access the Service if you are under the age of 13; You shall restrict use by minors, and you will deny access to children under the age of 13. You accept full responsibility for any unauthorized use of the Service by minors.

- You shall not (or attempt to) purchase, sell, rent or give away your Account, create an Account using a false identity or information, or on behalf of someone other than yourself; You shall not use the Service if you have previously been removed or banned by SPIN.

- You shall use your Account only for non-commercial purposes; You shall not use the Service to advertise, or solicit, or transmit any commercial advertisements, including chain letters, junk or spam e-mail or repetitive or misleading messages to anyone.

Login information and Your Account

You may be required to select a password for your Account or you may also use other credentials to access the Account ("Login Information"). You shall not share the Account or the

Login Information, nor let anyone else access your Account or do anything else that might jeopardize the security of your Account. In the event you become aware of or reasonably suspect any breach of security, including without limitation any loss, theft, or unauthorized disclosure of the Login Information, you must immediately notify SPIN and modify your Login Information. You are solely responsible for maintaining the confidentiality of the Login Information, and you will be responsible for all uses of the Login Information, including purchases, whether or not authorized by you. You are responsible for anything that happens through your Account.

SPIN reserves the right to remove or reclaim any usernames at any time and for any reason, including but not limited to claims by a third party that a username violates the third party's rights.

The Service supports only one Account per game on a supported device.

License Limitations

Any use of **the Service** in violation of these License Limitations is strictly prohibited, can result in the immediate revocation of **your limited license** and may subject you to liability for violations of law.

You agree that you will not, under any circumstances:

- Engage in any act that SPIN deems to be in conflict with the spirit or intent of the Service or make improper use of SPIN's support services.
- Use or take part (directly or indirectly) in the use of cheats, exploits, automation software, bots, hacks, mods or any unauthorized third-party software designed to modify or interfere with **the Service**, any SPIN game or any SPIN game experience.
- Modify or cause to be modified any files that are a part of **the Service** or any SPIN game without SPIN's express written consent.
- Disrupt, interfere with or otherwise adversely affect the normal flow of **the Service** or otherwise act in a manner that may negatively affect other users' experience when using **the Service** or playing SPIN's games. This includes win trading and any other kind of manipulation of rankings, taking advantage of errors in the Service to gain an unfair edge over other players and any other act that intentionally abuses or goes against the design of **the Service**.
- Disrupt, overburden, or aid or assist in the disruption or overburdening of any computer or server ("Server") **used to offer or support the Service or any SPIN game environment**.
- Institute, assist, or become involved in any type of attack, including without limitation distribution of a virus, denial of service attacks upon the Service, or other attempts to disrupt the Service or any other person's use or enjoyment of the Service.
- Attempt to gain unauthorized access to the Service, Accounts registered to others or to the computers, Servers, or networks connected to the Service by any means other than the user interface provided by SPIN, including but not limited to, by circumventing or modifying, attempting to circumvent or modify, or encouraging or assisting any other person to circumvent or modify, any security, technology, device, or software that is part of the Service.
- Post any information that is abusive, threatening, obscene, defamatory, libelous, or racially, sexually, religiously, or otherwise objectionable or offensive or engage in ongoing toxic behavior, such as by repeatedly posting information on an unsolicited basis.
- Post any information that contains nudity, excessive violence, or offensive subject matter or that contains a link to such content.
- Attempt to, or harass, abuse, or harm, or advocate or incite harassment, abuse, or harm of another person, group, including SPIN employees, including SPIN's customer service representatives.

- Make available through the Service any material or information that infringes any copyright, trademark, patent, trade secret, right of privacy, right of publicity, or other right of any person or entity or impersonates any other person, including without limitation a SPIN employee.
- Reverse engineer, decompile, disassemble, decipher or otherwise attempt to derive the source code for any underlying software or other intellectual property used to provide the Service or any SPIN game, or to obtain any information from the Service or any SPIN game using any method not expressly permitted by SPIN.
- Solicit or attempt to solicit Login Information or any other login credentials or personal information from other users of the Service or any SPIN game.
- Collect or post anyone's private information, including personally identifiable information (whether in text, image or video form), identification documents, or financial information through the Service.

SPIN reserves the right to determine what conduct it considers to be in violation of the rules of use or otherwise outside the intent or spirit of these Terms of Service or the Service itself. SPIN reserves the right to take action as a result, which may include terminating your Account and prohibiting you from using the Service in whole or in part.

1.2. Suspension and Termination of Account and Service

Without limiting any other remedies, spin may limit, suspend, terminate, modify, or delete accounts or access to the service or portions thereof if you are, or spin suspects that you are, failing to comply with any of these terms of service or for any actual or suspected illegal or improper use of the service, with or without notice to you. you can lose your user name and persona in the service as a result of account termination or limitation, as well as any benefits, privileges, earned items and purchased items associated with your use of the service, and spin is under no obligation to compensate you for any such losses or results.

without limiting our other remedies, we may limit, suspend or terminate the service and user accounts or portions thereof, prohibit access to our games and sites, and their content, services and tools, delay or remove hosted content, and take technical and legal steps to prevent users from accessing the service if we believe that they are creating risk or possible legal liabilities, infringing the intellectual property rights of third parties, or acting inconsistently with the letter or spirit of our terms or policies. additionally, we may, in appropriate circumstances and at our sole discretion, suspend or terminate accounts of users who may be repeat infringers of third party intellectual property rights.

spin reserves the right to terminate any account that has been inactive for 180 days.

SPIN reserves the right to stop offering and/or supporting the Service or a particular game or part of the Service at any time, at which point your license to use the Service or a part thereof will be automatically terminated. In such event, SPIN shall not be required to provide refunds, benefits or other compensation to users in connection with such discontinued Service

. Termination of your Account can include disabling your access to the Service or any part thereof including any content you submitted or others submitted.

You may terminate your Account at any time and for any reason.

2. Ownership

2.1. Games and Service

All rights, title and interest in and to the Service (including without limitation any games, titles, computer code, themes, objects, characters, character names, stories, dialogue, catch phrases, concepts, artwork, animations, sounds, musical compositions, audio-visual effects, methods of

operation, moral rights, documentation, in-game chat transcripts, character profile information, recordings of games played using a SPIN game client, and the SPIN game clients and server software) are owned by SPIN.

SPIN reserves all rights, including without limitation, all intellectual property rights or other proprietary rights, in connection with its games and the Service.

2.2. Accounts

Not with standing anything to the contrary herein, you acknowledge and agree that you shall have no ownership or other property interest in the account, and you further acknowledge and agree that all rights in and to the account are and shall forever be owned by and inure to the benefit of SPIN.

2.3. Virtual Items

SPIN owns, has licensed, or otherwise has rights to use all of the content that appears in the Service or in SPIN games. Notwithstanding any provision to the contrary herein, you agree that you have no right or title in or to any content that appears in the Service, including without limitation the virtual goods, points or currency appearing or originating in any SPIN game, whether earned in a game or purchased from SPIN, or any other attributes associated with an Account or stored on the Service.

3. User Content

3.1. Submission of User Content

"User Content" means any communications, images, sounds, and all the material, data, and information that you upload or transmit through a SPIN game client or the Service, or that other users upload or transmit, including without limitation any chat text. By transmitting or submitting any User Content while using the Service, you affirm, represent and warrant that such transmission or submission is (a) accurate and not confidential or misleading; (b) not in violation of any laws, contractual restrictions or other third party rights, and that you have permission from any third party whose personal information or intellectual property is comprised in the User Content; (c) free of viruses, adware, spyware, worms or other malicious code; and (d) you acknowledge and agree that any of your personal information within such content will at all times be processed by SPIN in accordance with its Privacy Policy.

3.1.1. Content Screening

SPIN assumes no responsibility for the conduct of any user submitting any User Content, and assumes no responsibility for monitoring the Service for inappropriate content or conduct. We do not, and cannot, pre-screen or monitor all User Content. Your use of the Service is at your own risk. By using the Service, you may be exposed to User Content that is offensive, indecent or otherwise not in line with your expectations. You bear all risks associated with the use of any User Content available in connection with the Service. At our discretion, our representatives or technology may monitor and/or record your interaction with the Service or communications (including without limitation chat text) when you are using the Service.

By entering into these Terms of Service, you hereby provide your irrevocable consent to such monitoring and recording. You acknowledge and agree that you have no expectation of privacy concerning the transmission of any User Content, including without limitation chat text or voice communications.

SPIN reserves the right in its sole discretion to review, monitor, prohibit, edit, delete, disable access to or otherwise make unavailable any User Content (including without limitation your User Content) without notice for any reason or for no reason at any time. If at any time SPIN chooses, in its sole discretion, to monitor the Service, SPIN nonetheless assumes no responsibility for User Content and assumes no obligation to modify or remove any

inappropriate User Content. We have the right, but not the obligation, in our sole discretion to edit, refuse to post, or remove any User Content.

3.2. Information Use by Other Members of the Service

3.2.1. Public Discourse

The Service may include various forums, blogs and chat features where you can post User Content, including your observations and comments on designated topics. SPIN cannot guarantee that other members will not use the ideas and information that you share. Therefore, if you have an idea or information that you would like to keep confidential and/or don't want others to use, do not post it on the Service. SPIN shall have no responsibility to evaluate, use or compensate you for any ideas or information you may choose to submit.

3.2.2. Responsible For Your Own Content

You are solely responsible for the information that you post on, through or in connection with the Service and that you provide to others. SPIN may reject, refuse to post or delete any User Content for any or no reason, including, but not limited to, User Content that in the sole judgment of SPIN violates these Terms of Service.

3.2.3. Your License to SPIN

You hereby grant to SPIN an irrevocable, perpetual, transferable, fully paid-up, royalty-free, worldwide license (including the right to sublicense and assign to third party) and right to copy, reproduce, fix, adapt, modify, create derivative works from, manufacture, commercialize, publish, distribute, sell, license, sublicense, transfer, lease, transmit, publicly display, publicly perform, or provide access to electronically, broadcast, communicate to the public by telecommunication, display, perform, enter into computer memory, and use and practice, in any way, your User Content as well as all modified and derivative works thereof in connection with our provision of the Service, including marketing and promotions of the Service. You also hereby grant to SPIN the right to authorize others to exercise any of the rights granted to SPIN under these Terms of Service. You further hereby grant to SPIN the unconditional, irrevocable right to use and exploit your name, likeness and any other information or material included in any User Content and in connection with any User Content, without any obligation to you. Except as prohibited by law, you waive any rights of attribution and/or any moral rights you may have in your User Content, regardless of whether your User Content is altered or changed in any manner. SPIN does not claim any ownership rights in your User Content and nothing in these Terms of Service is intended to restrict any rights that you may have to use and exploit your User Content. SPIN has no obligation to monitor or enforce your intellectual property rights in or to your User Content.

3.3. User Interactions

You are solely responsible for your interactions with other users of the Service and any other parties with whom you interact through the Service and/or SPIN games. SPIN reserves the right, but has no obligation, to become involved in any way with these disputes. You will fully cooperate with SPIN to investigate any suspected unlawful, fraudulent or improper activity, including, without limitation, granting SPIN access to any password-protected portions of your Account.

If you have a dispute with one or more users, you release us (and our officers, directors, agents, subsidiaries, joint ventures and employees) from claims, demands and damages (actual and consequential) of every kind and nature, known and unknown, arising out of or in any way connected with such disputes.

4. Updates to the Service

You understand that the Service is an evolving one. SPIN may require that you accept updates to the Service and to SPIN's games you have installed on your device or computer. You acknowledge and agree that SPIN may update the Service and SPIN games, with or without notifying you. You may need to update third party software from time to time in order to receive the Service and play SPIN games.

5. Disclaimer of Warranties

Without limiting spin's liability under section 7 below, the service is provided on an "as is" and "as available" basis for your use, without warranties of any kind, express or implied, including without limitation the warranties of merchantability, fitness for a particular purpose, title, non-infringement, and those arising from course of dealing or usage of trade. spin does not warrant that you will be able to access or use the service at the times or locations of your choosing; that the service will be uninterrupted or error-free; that defects will be corrected; or that the game or the service are free of viruses or other harmful components.

Some jurisdictions do not allow the exclusion of certain warranties. Accordingly, some of the above disclaimers may not apply to you.

You agree to indemnify, defend and hold SPIN (and our officers, directors, agents, subsidiaries, joint ventures and employees) harmless from any claim, demand, damages or other losses, including reasonable attorneys' fees, asserted by any third-party resulting from or arising out of your use of the Service, or any breach by you of these Terms of Service, however the foregoing does not apply if the infringement of rights is not attributable to your intentional or negligent behavior.

6. Dispute Resolution and Law

If a dispute arises between you and SPIN, we strongly encourage you to first contact us directly to seek a resolution by going to our customer support site at <https://support.spin.com/>. **If you are a resident of the LEBANON, these Terms of Service and any dispute arising out of or related to it or Privacy Policy or the Service shall be governed in all respects by Lebanese law, without regard to conflict of law provisions.** You agree that any claim or dispute you may have against SPIN must be resolved exclusively by a court located in Lebanon.

7. Severability

You and SPIN agree that if any portion of these Terms of Service or of the SPIN Privacy Policy is found illegal or unenforceable, in whole or in part by any court of competent jurisdiction, such provision shall, as to such jurisdiction, be ineffective solely to the extent of such determination of invalidity or unenforceability without affecting the validity or enforceability thereof in any other manner or jurisdiction and without affecting the remaining provisions of the terms, which shall continue to be in full force and effect.

8. General Provisions

8.1. Assignment

SPIN may assign or delegate these Terms of Service and/or the SPIN Privacy Policy, in whole or in part, to any person or entity at any time with or without your consent. You may not assign or delegate any rights or obligations under the Terms of Service or Privacy Policy without SPIN's prior written consent, and any unauthorized assignment and delegation by you is ineffective.

8.2. Supplemental Policies

SPIN may publish additional policies related to specific services such as forums, contests or loyalty programs. Your right to use such services is subject to those specific policies and these Terms of Service.

8.3. Entire Agreement

These Terms of Service, any supplemental policies and any documents expressly incorporated by reference herein (including the SPIN Privacy Policy), contain the entire understanding of you and SPIN, and supersede all prior understandings of the parties hereto relating to the subject matter hereof, whether electronic, oral or written, or whether established by custom, practice, policy or precedent, between you and us with respect to the Service.

8.4. No Waiver

The failure of SPIN to require or enforce strict performance by you of any provision of these Terms of Service or the SPIN Privacy Policy or failure to exercise any right under them shall not be construed as a waiver or relinquishment of SPIN's right to assert or rely upon any such provision or right in that or any other instance.

The express waiver by SPIN of any provision, condition, or requirement of these Terms of Service or the SPIN Privacy Policy shall not constitute a waiver of any future obligation to comply with such provision, condition or requirement.

Except as expressly and specifically set forth in these Terms of Service, no representations, statements, consents, waivers, or other acts or omissions by SPIN shall be deemed a modification of these Terms of Service nor legally binding, unless documented in physical writing, hand signed by You and a duly appointed officer of SPIN.

8.5. Equitable Remedies

You acknowledge that the rights granted and obligations made under these Terms of Service to SPIN are of a unique and irreplaceable nature, the loss of which shall irreparably harm SPIN and which cannot be replaced by monetary damages alone so that SPIN shall be entitled to injunctive or other equitable relief (without the obligations of posting any bond or surety or proof of damages) in the event of any breach or anticipatory breach by you.

You irrevocably waive all rights to seek injunctive or other equitable relief, or to enjoin or restrain the operation of the Service or any SPIN game, exploitation of any advertising or other materials issued in connection therewith, or exploitation of the Service or any content or other material used or displayed through the Service and agree to limit your claims to claims for monetary damages, limited by Section 7 (if any).

8.6. Force Majeure

SPIN shall not be liable for any delay or failure to perform resulting from causes outside the reasonable control of SPIN, including without limitation any failure to perform hereunder due to unforeseen circumstances or cause beyond SPIN's control such as acts of God, war, terrorism, riots, embargoes, acts of civil or military authorities, fire, floods, accidents, strikes, or shortages of transportation facilities, fuel, energy, labor or materials
