Spin: Terms & Conditions

By accepting the terms and conditions of Spin, you agree to the following:

Rules and Regulations:

- 1- The products that are won are samples and cannot be sold, exchanged, returned or traded commercially. Same applies for all the points or different services that are provided by SPIN.
- 2- All the points and / or the services won by any participant cannot be transferred to any other participant. They cannot be sold or exchanged under any circumstances.
- 3- All the points or services earned on the application platform have no monetary or real value outside of the platform itself.
- 4- SPIN is not responsible for inappropriate use, application or other related misusage of products or services that have been won on the platform.
- 5- If you are unable to collect your redeemed gifts and services you cannot claim them back after the delivery schedule.
- 6- Entering false or inaccurate information may result in your account being deactivated.

1. License

1.1. Grant of a Limited License to Use the Service

Subject to your agreement and continuing compliance with these Terms of Service and any other relevant SPIN policies, SPIN grants you a non-exclusive, non-transferable, non-sublicensable, revocable and limited license to access and use the Service for your own non-commercial entertainment purposes. You agree not to use the Service for any other purpose. The following restrictions apply to the use of the Service:

- You shall not create an Account or access the Service if you are under the age of 13; You shall restrict use by minors, and you will deny access to children under the age of 13. You accept full responsibility for any unauthorized use of the Service by minors.
- You shall not (or attempt to) purchase, sell, rent or give away your Account, create an Account using a false identity or information, or on behalf of someone other than yourself; You shall not use the Service if you have previously been removed or banned by SPIN.
- You shall use your Account only for non-commercial purposes; You shall not use the Service to advertise, or solicit, or transmit any commercial advertisements, including chain letters, junk or spam e-mail or repetitive or misleading messages to anyone.

Login information and Your Account

The Service supports only one Account per game on a supported device.

License Limitations

Any use of **the Service** in violation of these License Limitations is strictly prohibited, can result in the immediate revocation of **your limited license** and may subject you to liability for violations of law.

You agree that you will not, under any circumstances:

- Engage in any act that SPIN deems to be in conflict with the spirit or intent of the Service or make improper use of SPIN's support services.
- Use or take part (directly or indirectly) in the use of cheats, exploits, automation software, bots, hacks, mods or any unauthorized third-party software designed to modify or interfere with the Service, any SPIN game or any SPIN game experience.
- Modify or cause to be modified any files that are a part of the Service or any SPIN game without SPIN's express written consent.

1.2. Suspension and Termination of Account and Service

Without limiting any other remedies, spin may limit, suspend, terminate, modify, or delete accounts or access to the service or portions thereof if you are, or spin suspects that you are, failing to comply with any of these terms of service or for any actual or suspected illegal or improper use of the service, with or without notice to you. you can lose your user name and persona in the service as a result of account termination or limitation, as well as any benefits, privileges, earned items and purchased items associated with your use of the service, and spin is under no obligation to compensate you for any such losses or results.

without limiting our other remedies, we may limit, suspend or terminate the service and user accounts or portions thereof, prohibit access to our games and sites, and their content, services and tools, delay or remove hosted content, and take technical and legal steps to prevent users from accessing the service if we believe that they are creating risk or possible legal liabilities, infringing the intellectual property rights of third parties, or acting inconsistently with the letter or spirit of our terms or policies. additionally, we may, in appropriate circumstances and at our sole discretion, suspend or terminate accounts of users who may be repeat infringers of third party intellectual property rights.

spin reserves the right to terminate any account that has been inactive for 180 days. SPIN reserves the right to stop offering and/or supporting the Service or a particular game or part of the Service at any time, at which point your license to use the Service or a part thereof will be automatically terminated. In such event, SPIN shall not be required to provide refunds, benefits or other compensation to users in connection with such discontinued Service

. Termination of your Account can include disabling your access to the Service or any part thereof including any content you submitted or others submitted.

You may terminate your Account at any time and for any reason.

2. Ownership

2.1. Games and Service

All rights, title and interest in and to the Service (including without limitation any games, titles, computer code, themes, objects, characters, character names, stories, dialogue, catch phrases, concepts, artwork, animations, sounds, musical compositions, audio-visual effects, methods of

SPIN reserves all rights, including without limitation, all intellectual property rights or other proprietary rights, in connection with its games and the Service.

2.2. Accounts

Not with standing anything to the contrary herein, you acknowledge and agree that you shall have no ownership or other property interest in the account, and you further acknowledge and agree that all rights in and to the account are and shall forever be owned by and inure to the benefit of SPIN.

2.3. Virtual Items

SPIN owns, has licensed, or otherwise has rights to use all of the content that appears in the Service or in SPIN games. Notwithstanding any provision to the contrary herein, you agree that you have no right or title in or to any content that appears in the Service, including without limitation the virtual goods, points or currency appearing or originating in any SPIN game, whether earned in a game or purchased from SPIN, or any other attributes associated with an Account or stored on the Service.

3. User Content

3.1. Submission of User Content

"User Content" means any communications, images, sounds, and all the material, data, and information that you upload or transmit through a SPIN game client or the Service, or that other users upload or transmit, including without limitation any chat text. By transmitting or submitting any User Content while using the Service, you affirm, represent and warrant that such transmission or submission is (a) accurate and not confidential or misleading; (b) not in violation of any laws, contractual restrictions or other third party rights, and that you have permission from any third party whose personal information or intellectual property is comprised in the User Content; (c) free of viruses, adware, spyware, worms or other malicious code; and (d) you acknowledge and agree that any of your personal information within such content will at all times be processed by SPINI in accordance with its Privacy Policy.

3.1.1. Content Screening

SPIN assumes no responsibility for the conduct of any user submitting any User Content, and assumes no responsibility for monitoring the Service for inappropriate content or conduct. We do not, and cannot, pre-screen or monitor all User Content. Your use of the Service is at your own risk. SPIN has no obligation to monitor or enforce your intellectual property rights in or to your User Content.

3.3. User Interactions

You are solely responsible for your interactions with other users of the Service and any other parties with whom you interact through the Service and/or SPIN games. SPIN reserves the right, but has no obligation, to become involved in any way with these disputes. You will fully cooperate with SPIN to investigate any suspected unlawful, fraudulent or improper activity, including, without limitation, granting SPIN access to any password-protected portions of your Account.

If you have a dispute with one or more users, you release us (and our officers, directors, agents, subsidiaries, joint ventures and employees) from claims, demands and damages (actual and consequential) of every kind and nature, known and unknown, arising out of or in any way connected with such disputes.

4. Updates to the Service

You agree to indemnify, defend and hold SPIN (and our officers, directors, agents, subsidiaries, joint ventures and employees) harmless from any claim, demand, damages or other losses, including reasonable attorneys' fees, asserted by any third-party resulting from or arising out of your use of the Service, or any breach by you of these Terms of Service, however the foregoing does not apply if the infringement of rights is not attributable to your intentional or negligent behavior.

6. Dispute Resolution and Law

If a dispute arises between you and SPIN, we strongly encourage you to first contact us directly to seek a resolution by going to our customer support site at https://support.spin.com/. If you are a resident of the LEBANON, these Terms of Service and any dispute arising out of or related to it or Privacy Policy or the Service shall be governed in all respects by Lebanese law, without regard to conflict of law provisions. You agree that any claim or dispute you may have against SPIN must be resolved exclusively by a court located in Lebanon

7. Severability

You and SPIN agree that if any portion of these Terms of Service or of the SPIN Privacy Policy is found illegal or unenforceable, in whole or in part by any court of competent jurisdiction, such provision shall, as to such jurisdiction, be ineffective solely to the extent of such determination of invalidity or unenforceability without affecting the validity or enforceability thereof in any other manner or jurisdiction and without affecting the remaining provisions of the terms, which shall continue to be in full force and effect.

8. General Provisions

8.1. Assignment

SPIN may assign or delegate these Terms of Service and/or the SPIN Privacy Policy, in whole or in part, to any person or entity at any time with or without your consent. You may not assign or delegate any rights or obligations under the Terms of Service or Privacy Policy without SPIN's prior written consent, and any unauthorized assignment and delegation by you is ineffective.

8.2. Supplemental Policies

SPIN may publish additional policies related to specific services such as forums, contests or loyalty programs. Your right to use such services is subject to those specific policies and these Terms of Service.

8.3. Entire Agreement

These Terms of Service, any supplemental policies and any documents expressly incorporated by reference herein (including the SPIN Privacy Policy), contain the entire understanding of you and SPIN, and supersede all prior understandings of the parties hereto relating to the subject matter hereof, whether electronic, oral or written, or whether established by custom, practice, policy or precedent, between you and us with respect to the Service.

8.4. No Waiver

Except as expressly and specifically set forth in this these Terms of Service, no representations, statements, consents, waivers, or other acts or omissions by SPIN shall be deemed a modification of these Terms of Service nor legally binding, unless documented in physical writing, hand signed by You and a duly appointed officer of SPIN.

8.5. Equitable Remedies

You acknowledge that the rights granted and obligations made under these Terms of Service to SPIN are of a unique and irreplaceable nature, the loss of which shall irreparably harm SPIN and which cannot be replaced by monetary damages alone so that SPIN shall be entitled to injunctive or other equitable relief (without the obligations of posting any bond or surety or proof of damages) in the event of any breach or anticipatory breach by you.

You irrevocably waive all rights to seek injunctive or other equitable relief, or to enjoin or restrain the operation of the Service or any SPIN game, exploitation of any advertising or other materials issued in connection therewith, or exploitation of the Service or any content or other material used or displayed through the Service and agree to limit your claims to claims for monetary damages, limited by Section 7 (if any).
